| Why? | Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do. |
| What? | <p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> • Social Security Number and Income • Account Balance and Payment History • Transaction History and Credit History <p>When you are no longer our customer, we continue to share your information as described in this notice.</p> |
| How? | All financial companies need to share personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons to share; and whether you can limit this sharing. |

| What we do | |
| How does PARKEBANK protect my personal information? | <p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p> <p>Also, we restrict the access to your personal information to only those employees who have a need to know that information.</p> |
| How does PARKEBANK collect my personal information? | <p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> • Open an account or pay bills • Apply for a loan or deposit money • Use your debit card <p>We also collect your information from others, such as credit bureaus, affiliates, or other companies.</p> |
| Why can't I limit all sharing? | <p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> • sharing for affiliates' everyday business purposes – information about your creditworthiness. • affiliates from using your information to market to you • sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing. See below.</p> |
| What happens when I limit sharing for an account I hold jointly with someone else? | <p>Your choices will apply only to you. Anyone else on the joint account must independently limit sharing. If one joint account holder limits sharing and the other account holder does not, information about the person who does not opt out may be shared with our nonaffiliates for marketing purposes.</p> |

| Definitions | |
| Affiliates | <p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • Parke Bank does not have affiliates |
| Nonaffiliates | <p>Companies not related by common ownership or control. They can be financial and non financial companies.</p> <ul style="list-style-type: none"> • Nonaffiliates we share with can include marketing companies. |
| Joint marketing | <p>A formal agreement between nonaffiliated companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> • Our joint marketing partners include credit card companies. |
